Portions consumed: All of the chicken, 1 peanut butter cookie, half of one cinnamon roll, half of the sweet rice, 1 slice of bread and half cup of the BBQ beans.

The acts of grace, forgiveness and mercy you demonstrated toward the person who had taken so much from you, by bringing to me in prison my own baby and grandchild, right before my scheduled execution. No rapist, murderer, terrorist, butcher, barbarian; not even old Beelzebub himself; could withstand such a blast of glorious Light and continue too walk in darkness. My continued statement, I am not the person I was, I've been transformed. Some things can't be undone, I seek forgiveness. The next words will be spoken in my native language tongue.

REMARKS: After the first drug began to take effect he completed speaking in tongue and said "these last words..." At 10:53, he was quiet and then at 10:55 for about 10 seconds his chest raised and lowered as though he was coughing but there was no coughing sound; during that 10 seconds, his hands remained relaxed and he did not have a grimace or indication of distress on his face. Two minutes later at 10:57 pm, a check for consciousness was completed followed by administration of the second two drugs.
