MOTION TO WITHDRAW ORDER OF COURT SETTING A DATE FOR EXECUTION IN DEATH PENALTY CASE

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES NICHOLAS LAHOOD, Criminal District Attorney of Bexar County, Texas by and through the undersigned Assistant Criminal District Attorney, and respectfully moves this Court to withdraw the order of the court setting a date for execution and in support would show:

On August 23, 2017, Governor Abbott declared a state of disaster in 30 counties, including Harris County. On August 25, 2017, Hurricane Harvey made landfall on the Texas coast, displacing many families in Harris County and the surrounding areas. A portion of Mr. Castillo's defense team resides and works in Harris County and the surrounding areas, and has been affected by Hurricane Harvey.

On August 29, 2017, the State contacted Mr. David Dow, in his capacity as a representative of Mr. Castillo. The State informed Mr. Dow that, under these extraordinary circumstances, the State would move to withdraw the execution date

and seek a new date of December 14, 2017. Mr. Dow agreed to the withdrawal and the new date, and expressed no opposition to this motion. This motion is submitted concurrently with the documents setting the new execution date.

WHEREFORE, PREMISES CONSIDERED, the State respectfully requests this Court to withdraw its order setting the Defendant's execution date and recall the warrant of execution.
