**ORDER MODIFYING EXECUTION DATE  
AND RECALLING WARRANT OF EXECUTION**

The Court has reviewed the State’s Motion to Modify Execution Date and finds that the motion should be granted.

**IT IS THEREFORE ORDERED** that the prior order of this Court setting the Defendant’s execution date as August 30, 2018, is hereby modified and the Defendant, Joseph C. Garcia, who has been adjudged to be guilty of capital murder as charged in the indictment and whose punishment has been assessed by the verdict of the jury and judgment of the Court at Death, shall be kept in custody by the Director of the Texas Department of Criminal Justice, Institutional Division, until the 4<sup>th</sup> day of December, 2018, upon which day, at the Texas Department of Criminal Justice, Institutional Division, at some time after the hour of six o’clock p.m., in a room arranged for the purpose of execution, the said Director, acting by and through the executioner designated by said Director, as provided by law, is hereby commanded, ordered and directed to carry out this sentence of death by intravenous injection of a substance or substances in a lethal quantity sufficient to cause the death of the said Joseph C. Garcia until the said Joseph C. Garcia is dead.. Such procedure shall be

determined and supervised by the said Director of the Texas Department of Criminal Justice, Institutional Division.

Within **10 days** of the signing of this order, the Clerk of this Court shall issue and deliver to the Sheriff of Dallas County, Texas, a Death Warrant in accordance with this Order, directed to the Director of the Texas Department of Criminal Justice, Institutional Division, at Huntsville, Texas, commanding him, the said Director, to put into execution the Judgment of Death against the said Joseph C. Garcia.

The Sheriff of Dallas County, Texas is hereby ordered, upon receipt of said Death Warrant, to deliver said Warrant to the Director of the Texas Department of Criminal Justice, Institutional Division, Huntsville, Texas.

**IT IS FURTHER ORDERED** that the previous Warrant of Execution issued in this case is hereby recalled.
